



RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AND PARENTAL CONSENT AGREEMENT

In consideration of being permitted to participate in any way in the DC Baseball, LLC dba DC Home Base facility and related events/activities, the undersigned acknowledges, appreciates, and agrees that:

The risk and dangers of serious bodily injury from the activities are significant, including the potential for permanent paralysis and even death, and while particular rules, equipment, and personal discipline may reduce the risk, the risk of serious injury does exist. I understand the nature of such activities and that I am qualified, in good health, and in proper physical condition to participate in such activity.

These risks and dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the activity, or the condition in which the activity takes place. I knowingly and freely assume all risks, both known and unknown, even if arising from the negligence of the Releasees or others, and assume full responsibility for my participation. If at any time I observe any unusual hazard or believe conditions to be unsafe, I will remove myself from participation in the activity and bring such attention to a DC Home Base instructor or staff member immediately.

The risk to have contact with individuals, who have been exposed to and/or have been diagnosed with one or more communicable diseases, including but not limited to COVID-19 or other medical conditions, diseases, or maladies does exist, and it is impossible to eliminate the risk that I could be exposed to and/or become infected through contact with or in close proximity with an individual with a communicable disease.

I further acknowledge that I will observe and follow all rules, regulations, and policies of DC Home Base. I understand the company is not responsible for property that is lost, stolen, or damaged while in, on, or about the premises.

In consideration of my participation in the facility and related activities, I hereby release, waive, discharge, covenant not to sue, and agree to indemnify and hold harmless for any and all purposes DC Baseball, LLC, their owners, officers, employees, agents, members, and volunteers ("Releasees") from any and all liabilities, claims, illnesses, or injuries, including death, that may be sustained by myself or my family, in connection with the use of the DC Home Base facility or while on premises owned or controlled by the Releasees.
